Rules & Regulations**

- Pets must be registered in advance. One form per pet.
- **No registration fee required.**
- We do not allow political candidates or publicity of such, social issues or targeted special interest groups. By making an application entry, Understand the parade committee has final decision and authority.
- All pets must be restrained. Female pets in heat will not be permitted.
- Costumed handlers encouraged to dress in the "Spirit of Mardi Gras". Entries that are Creative & Zany are encouraged
- Children 12 and under with pet in the parade must be accompanied by an adult (minimum one adult per child)
- Yard tractors, grocery carts, wagons, golf carts, battery operated children vehicles may be used.
- For safety reasons **No cars or trucks or large tractors will be permitted.**
- Adults and children are encouraged to participate with their pets.
- **Parade participants check in at 1 p.m. on 9<sup>th</sup> St & Main St.**
- Parade route will start at 9<sup>th</sup> & Main traveling East to Palmetto Street.
- Trophies will be presented to each Category and Performance. Judges decision is final.
- Talent Show limited to first thirty entries – 2 Minute Stage time.
- Winners will be announced immediately following the parade at Palmetto Street Stage!
