If your policy expires prior to the event then your current policy will be sufficient to apply. However your insurance company must send us an updated certificate 7 days prior to event. No vendor will be allowed to set up without meeting insurance requirements and no refunds will be made for vendor's failure to comply.

General Rules and Regulations:

- Vendor displays must stay in designated space this includes display racks, tables, etc.
- Vendors may set up either Friday evening or Saturday Morning; all vehicles must be off the road by 9:00am Saturday, February 20, 2010.
- **No obscene or drug related merchandise as determined in Leesburg Partnership, Inc.'s sole discretion is to be displayed or sold at the event.**
- We do not allow political candidates or publicity of such, social issues or targeted special interest groups.
- All vendors must be in the spirit of Mardi Gras, Children or Pets.
- Vendors with booths must be removed by 6pm.
- No food, water or beverage sales are allowed to be sold from your booth including free water.
- We do not offer "exclusive merchandise category".
- Electricity will be provided for all locations: **Vendors are required to provide 125' extension cord: 110 volt, 20 amp-12/2 (wire gauge/#wires) with ground, 30 amp-10/2 with ground; 220 volt, 30 amp-10/3 with ground, 50 amp-8/3 with ground.**
- All vendors must leave location clean of trash and debris if you plan on being invited back next year! Each location will be inspected and noted on what condition you left your area in.
- ALL Vendors must check-in at _____ to find your location.
- **Applications will be date stamped and locations will be awarded to earliest applicants first. Consideration will be made for repeat vendors.**
